That is, the host, or the cohost of the town halls, and doing a short introduction and followed by a high level overview of the master plan.

Just kind of where we have you know how we've gotten to where we are now and and where we're going.

And then we'll spend about 90 minutes in small groups, so 10 to 12 people.

Each group will have a facilitator and a notetaker, and they'll work with the participants to get through each one of the seven subcommittees, and so they developed three questions, and for each of the subcommittee areas.

And they're very general questions and actually just thought I had opened earlier.

And so they for housing and aging in place, the three questions are what are some of the challenges or benefits that you currently experience with housing and aging in place?

And the second question is how do you see your housing needs and preferences changing over the next 10 years?

And then the third question is what is your hope for the future when it comes to housing and aging in place?

And so we purposely left those pretty wide open.

We wanna be able to get feedback without.

Making people feel like they're tied into the recommendations that we put forward,

we will have the recommendations there for people to look through, but we didn't want them to feel like they had to stay within those.

We purposely left them pretty general questions and pretty wide open and the facilitators also have some prompting questions if people aren't really talking in a particular section.

But we hope that people can move through all seven areas and in those smaller groups within about that 90 minutes.

And then if there's time left at the end and we will have each group do like a a report out within their own small group of kind of those high level areas that came up through the conversations just to make sure that there was nothing missed to answer any questions, that sort of thing.

Like if somebody that's acting kind of shy or we have somebody that's really trying to talk over everyone or kind of dominating that time we we are gonna have no cards there for people to be able to write those things down to try to keep that conversation going and make sure that everybody can get the input that they would like to share.

And then we do have a QR code that we're gonna have up to that will direct them to the website and we've updated the website to be able to put I they can put any comment, questions, suggestion or whatever they want.

And then there's also a space for them to leave their name, address or not address. Name, email address, or phone number if they want us to contact them back for any reason.

So we'll be looking at all of that also once we get through the town halls and get a chance to put all of that information together and we will try to get all of that information, all that feedback for your subcommittee back to you in April. So that that's the goal for the town halls and some of them are having food and snacks, some are not and it's just kind of up to the area agency on aging what they were wanting to do.

I'm we are still looking for volunteers, so if you or you know staff are available in the Cape Girardeau area or the Joplin area, we could still use some volunteers in those

areas.

The Cape Girardeau locations, expecting up to 1500 people so as you can imagine we need a large number of people to try to assist that that larger crowd.

So, and then Joplin's expecting around 300.

So we do have enough volunteers in the other areas of course, of if you're there and we recognize you and we need help, we'll probably grab you.

So just fair warning on that ohm, but just wanted to give you just a little bit of info on the town halls and then look for the survey to be coming out hopefully within the next couple of months.
