This reporting requirement is separate from completing the entire SF-425 as denoted in the financial reporting term.
4. Special Clause for Change in Key Personnel: Per 2 CFR 200.308, recipients of federal funds must request approval from the grantor for a number of changes related to the grant, including a Change in Key Personnel identified in the application for federal funds or in the grant award.
