### EDUCATIONAL RESOURCES OFFER

The Department of Health and Senior Services' Prenatal Substance Use Prevention program is searching for an organization interested in housing life like infant manikins. The set of manikins represent infants with Fetal Alcohol Syndrome (FAS), prenatal drug exposure, and healthy characteristics. Organizations can utilize the manikins to demonstrate the effects of prenatal substance use to promote healthy pregnancies. The drug-affected manikin will emit the effects of withdrawal. The FAS manikin features some of alcohol's devastating effects. Individuals visualize all three manikins together to compare the effects of prenatal substance use. The manikins are provided at no cost along with educational materials, but does require bi-annually reporting on the usage.
