Some bills with EMS issues are on the Governor's desk waiting for signature. • Community Paramedic (CP) proposed regulatory language has been filed for comment. It has a problematic date for grandfathering in the education already obtained by some EMS agencies involved in existing Community Paramedic programs. The Scope of Practice in the proposed regulations also refers to the 1998 rules which would limit the CP to being able to do less than what Paramedics are able to do now. MAA, MEMSA, ADAM and MARCER have endorsed sending letters of comment to address the issue. <i>Mark Alexander moved SAC draft a similar letter with the same message and send it as a comment before July 15 when the comment period expires. Ben Chlapek seconded. Motion carried.</i> 	Dr. Andrews will send the letter from SAC addressing the concerns about the proposed regulatory language before the July 15 close of comments date.
