Home Owners

In Missouri, licensure is not required if you are a homeowner or property owner who is conducting an abatement project on your own home or dwelling unit so long as you or your Immediate family live there, and no child who has been identified as having an elevated blood lead level resides in the building.

Childhood Lead Poisoning...

is one of the most common pediatric health problems in the United States. In fact, lead can poison anyone, regardless of age, race or economic standing. Lead is most commonly found in the paint of houses built prior to 1978. Soil and water can also contain dangerous levels of lead.

<u>Lead Licensing Program:</u> Who we are and What we do

As part of the Missouri Department of Health and Senior Services, the Lead Licensing Program's mission is to prevent lead poisoning from improper lead abatement activities. As the regulatory authority for lead-bearing substance activities for the state of Missouri, the Program oversees all aspects of the industry. This includes accrediting training providers, licensing individuals and companies to provide services to the public, and to oversee those individuals and entities to ensure compliance with the regulations and the safety of the citizens of our state.



Training Accreditation

- Reviews training curricula to ensure that it meets regulations and provides the licensee the knowledge necessary to identify and control hazards
- Ensures training providers meet regulatory standards required to provide training

Professional Licensing



- Reviews applications and qualifications to determine compliance with licensing rules
- Administers state licensing examinations
- lssues Missouri lead licenses for lead abatement workers, lead abatement supervisors, lead inspectors, risk assessors, project designers, and lead abatement contractors
- Issues photo identification badges

Enforcement

- Conducts random audits of accredited training providers in the classroom to ensure that trainees are receiving training that meets state regulation
- Performs regulatory review of risk assessment and lead inspection reports
- Conducts on-site inspections and records review of residential lead abatement projects
- Investigates complaints
