Quality Assurance Process Improvement (QAPI)

QAPI IS COMING!

Section 6102 (c) of the Affordable Care Act requires CMS to promulgate a new QAPI regulation. The new QAPI regulation will include the requirement that all homes must submit to the Secretary a plan for the facility to meet QAPI standards and implement QAPI best practices, including how to coordinate the implementation of a QAPI plan with OAA activities conducted under existing regulations.

This work shop will provide the necessary tools and resources for you to guide your facility to compliance with Section 6102. A plan must be submitted to the Secretary. We will review the necessary steps and requirements of that plan. QAPI will replace traditional Quality Assurance Programs in facilities, building upon those programs but becoming part of the culture. That culture will require all staff, including non-managers (CNA's Charge Nurses, housekeepers, dietary aides, etc.) play an active role and have an active voice in QAPI. This is a huge project for facilities and compliance is not realistically achievable in a 30 day time span. You will need guidance, resources, tools and methods of examining current practices for improvement and revision of facility culture to include staff at all levels in the QAPI process.
