Dementia Care Mapping (DCM) is a method to evaluate the delivery of person-centered care and, in general, to improve the quality of care delivered to persons with dementia in formal care settings. DCM goes to the real heart of caring by striving to assess care from the viewpoint of the person with dementia. It involves making and recording detailed observations. DCM provides valuable, clear and reliable information for those concerned with quality care for people with dementia.

- Track culture change efforts
- Improve quality assurance program
- Evaluate and measure effectiveness of care planning
- Identify care partner training and development issues
- Evaluate and measure quality of dementia care and resident well-being
- Monitor challenging times of day and contributing factors

De Minner, RN, has been using DCM in Missouri homes since taking the Basic DCM User course in 2003. She became an advanced Mapper in 2004 and became a trainer in 2013. She has been in and around Missouri nursing homes since 1994 as an ADON, University of Missouri QIPMO nurse and a Primaris nurse.
