The five board-approved rules from November 2013 are still under review with the Governor's Office. Once completed, the rules will be filed with the Secretary of State's office.

Audit of 2014 license renewals – all are in compliance except for three licensees. A warning letter was issued to the licensees giving them a final opportunity to respond with his/her documentation. If they fail to respond, they will be referred to the Board at February meeting. This fulfills the regulatory requirement, 19 CSR 73-2.050(4).

Sally McKee attended the NAB Mid-Year meeting November 12-14, 2014 in San Francisco, California. She served as vice-chair of NAB's State Governance and Regulatory Issues Committee. Donald Aldridge from New York is the chair. This committee will gather information on how NAB can provide support for state boards, identify types of resources/support, and how NAB and the states can address the various state regulatory barriers. This goes hand-in-hand with the implementation of the professional practice analysis (PPA). The NAB Mid-Year meeting discussed the implementation of the PPA and how this impacts the future of long term care. Implementation is targeted for 2016 to produce the Health Services Executive (HSE) credentialing, HSE examinations, HSE Model Practice Act, and model statutory/regulatory language to expand licensing authority to include HSE. Sally was one of the four panelists during the November 13 morning panel discussion, "QAPI and Advancing Excellence: Strategies for Quality Improvement, Engagement and Compliance." Carol Scott, former LTC Ombudsman from Missouri, was on the panel representing Advancing Excellence.

## NHA Criteria

Sally McKee shared the results from the various organizations that obtained feedback regarding the board's recommendations on the nursing home administrator (NHA) criteria.

- Missouri League for Nursing surveyed 20 licensed NHAs at their October conference. The 20 attendees agreed that a high level of education is needed and indicated that the number of internship/practicum hours recommended may be a little high. In addition, some of the attendees suggested contacting Arkansas regarding their excellent AIT program.
- LTC Ombudsman obtained feedback from their volunteer ombudsmen. A bachelor's degree is recommended to be the minimum education rather than the associate's degree due to the increasing complexity of residents and their needs. They suggested that prospective NHA applicants take part in a surveyor training as part of the licensure process.
- Missouri Health Care Association (MHCA) and Missouri Association of Nursing Home Administrators (MANHA) collaborated and sent out a survey through Survey Monkey. The board reviewed the survey results. The survey received 44 responses and 32 of the responses are administrators currently managing a facility. 55% are in favor of raising the minimum education to an associate's degree and 92% agree that applicants without relevant experience should complete an internship.
- LeadingAge Missouri has not provided their feedback. Sally will follow up with the organization.

The board discussed the need to provide clear language in the regulation to define the education and experience criteria. A document providing the surrounding states' criteria was shared and reviewed briefly. The board requested for a survey to be sent from the office to obtain more feedback. Sally indicated that she will develop a survey and have it sent through the LTC Information Update listserve. An update and more information will be provided at the February meeting.

### **Nominating Committee**

Alexis Roam spoke for the Nominating Committee and presented the following for the 2015 slate of officers – Mike Roth, President; Mike Levitt, Vice President; and Dr. Razzaque, Secretary. No discussion and questions on the floor. Alexis Roam made the motion and seconded by Ann Harris to accept the recommendation. Motion carried unanimously.
