This cash award is based on final distribution of the FY 2020 appropriation for this program, using the updated meal counts submitted by all States and Tribal Organizations, and does not include the amount if the grantee elected to have US Foods (commodities). This amount contains the FY2020 final grant amount and a one-time supplement based on the same allocation formula.
