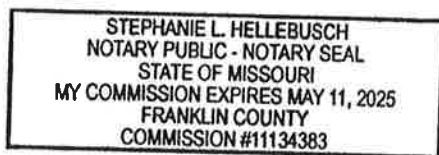
Before me, the undersigned authority, personally appeared, Douglas Tollison who, being by me duly sworn, deposed as follows:
