

The number of reported influenza cases for week 44 of the 2010-2011 season is at historic levels.

**Outbreaks/Closures of Influenza-like Illness:** No school closings have been reported for week 44 of the current season; nine school closings were reported for this week last season. No outbreaks have been reported for week 44 of the current season; one outbreak was reported for this week last season. No school closings or outbreaks have been reported season-to-date for the 2010-2011 season; fifty-four school closings and thirteen outbreaks were reported for the same period (week 40-week 44) during the 2009-2010 season.




The state rate of 1.88% in week 44, is below Missouri's ILI baseline of 2.47%.




ILINet baseline refers to the mean plus two standard deviations of the values during previous influenza seasons (week 40-20).

For the week ending November 6, 2010 (week 44), Missouri reported **No Activity** to the CDC. No Activity is defined as no laboratory-confirmed cases of influenza and no reported increase in the number of cases of ILI.

For the week ending October 30, 2010 (week 43), Flu View reported no states with widespread or regional. Two states reported local influenza activity, 22 states reported sporadic influenza activity and 26 states reported no activity. The influenza activity reported by state and territorial epidemiologists indicates geographic spread of influenza viruses, but does not measure the severity of influenza activity.

**Data Sources:** Laboratory-confirmed cases are reported to DHSS through the passive communicable disease surveillance system. Suspected influenza clusters and outbreaks are reported through the active surveillance system. Pneumonia and influenza deaths are reported through the DHSS Bureau of Vital Records. Influenza-like illness data by age category and total number of patient visits by week are reported voluntarily by participants in the U.S. Outpatient Influenza-like Illness Surveillance Network (ILINet).
