






ILINet baseline refers to the mean plus two standard deviations of the values during previous influenza seasons (week 40-20, 2008-2009)

The proportion of patient visits for influenza-like illness is 1.09% for week ending December 10, 2011 (Week 49). This is below Missouri’s baseline of 1.98%.

*ESSENCE ILI Threshold refers to the mean plus 2 standard deviations of the values during previous influenza seasons (week 40-20, 2006-2007) when influenza activity was low.



For the week ending December 10, 2011 (Week 49), Missouri reported **No activity** to the CDC. No activity is defined as influenza-like illness activity is low and there are no lab confirmed cases.

For the week ending December 3, 2011 (week 48), Flu View reported no states with widespread or regional influenza activity. One state reported local influenza activity, 30 states reported sporadic influenza activity and 19 states reported no activity. The influenza activity reported by state and territorial epidemiologists indicates geographic spread of influenza viruses, but does not measure the severity of influenza activity.

Data Sources: Laboratory-confirmed cases are reported to DHSS through the passive communicable disease surveillance system. Suspected influenza clusters and outbreaks are reported through the active surveillance system. Pneumonia and influenza deaths are reported through the DHSS Bureau of Vital Records. Influenza-like illness data by age category and total number of patient visits by week are reported voluntarily by participants in the U.S. Outpatient Influenza-like Illness Surveillance Network (ILINet).
