
# CONCUSSION BINGO: Are You Prepared?

Results Summary from the 2019 Missouri Regional "Sports Concussions: Facts, Fallacies and New Frontiers" Seminars

Featuring a comparison of result from 2016, 2017, and 2018

# INTRODUCTION

For the past four years, the Brain Injury Association of Missouri, Missouri Department of Health and Senior Services, and University of Missouri Kansas City - Institute for Human Development have collaborated with sponsors across the state to hold regional sports concussion seminars. The seminars, titled *Sports Concussions: Facts, Fallacies and New Frontiers*, provide quality information on traumatic brain injury (TBI) policy and procedure development to coaches, school administrators, school nurses, and first responders.

A self-assessment form, titled *Concussion BINGO – Are You Prepared?*, is shared with all seminar participants and is intended to gather information on if and how frequently schools across the state implement a variety of TBI screening and education policies and practices. Issues addressed on the *Concussion Bingo* assessment include coaches' education, safety equipment check, and "Return to Learn" form use.

### WHAT IS CONCUSSION BINGO?

During regional Sports Concussions: Facts, Fallacies and New Frontiers seminars, national and international experts discuss signs and symptoms of a possible concussion. Speakers also provide updates on concussion-related research and "Return-to-Learn" protocols that have been discussed in previous Sports Concussions: Facts, Fallacies and New Frontiers seminars. Examples of topics that speakers cover include baseline testing, how to encourage youth to report possible concussion symptoms, and concussion management strategies, which attendees may use to develop their team or school's Concussion Management Protocol.

As topics are discussed throughout the seminar, attendees are asked to complete the *Concussion BINGO* assessment with regard to their concussion management practices within their school or team (see Appendix A to review the *Concussion BINGO* assessment form items). Ratings for each item range from "0," or "does not currently implement the policy or practice item," to "5," or "yes, implementing 100% of the time." Additional ratings include: "1" = implementing less than 25% of the time; "2" = implementing between 25 and 49% of the time; "3" = implementing between 50 and 74% of the time; and "4" = implementing between 75 and 100% of the time.

To ensure that attendees understand the assessment items, attendees are given the opportunity to ask questions during the seminars.

# RESULTS

Results from the 2019 *Concussion BINGO* assessment, including to a comparison to 2016, 2017, and 2018 data, are discussed below.

### **2019 DEMOGRAPHICS**

Table 1 shows the response rate on the Concussion BINGO assessment for attendees of the 2019 Sports Concussions: Facts, Fallacies and New Frontiers seminars by region.

Table 1 key findings include:

- ✤ A total of 130 Concussion BINGO assessments were received from regional seminar attendees statewide in 2019.
- ♦ Over half of all responses were from either the Columbia region (*n*=50, 38.5%) or the St. Louis region (*n*=42 32.3%).
- ✤ The fewest number of *Concussion BINGO* assessment surveys were received from the Kansas City region (n=38, 29.2%).

### CONCUSSION BINGO

Table 2 displays concussion management policy and practice non-implementation rates in 2019 by region.


Table 2. Concussion management policy and practice implementation in 2019 by region

Table 2 key findings include:

- ✤ Most participants reported that the majority of the concussion management policies and practices were being implemented in their regions in 2019.
- In Columbia, many respondents reported that the following policies or practices were <u>not</u> being implemented within their school or team in 2019:
  - Certified Athletic Trainer (full-time) (not implementing: 60%)
  - Team Doctor (not implementing: 54%)
  - Ambulance at All Contests (not implementing: 44%)
  - Baseline Testing (not implementing: 42%)
- ✤ In Kansas City, many respondents reported that the following policies or practices were <u>not</u> being implemented within their school or team in 2019:
  - Ambulance at All Contests (not implementing: 65.8%)
  - Team Doctor (not implementing: 31.6%)
- ✤ In St. Louis, many respondents reported that the following policies or practices were <u>not</u> being implemented within their school or team in 2019:
  - Ambulance at All Contests (not implementing: 64.3%)
  - Team Doctor (not implementing: 47.6%)

*Figure 1* displays the average change in overall *Concussion BINGO* frequency ratings statewide for policies (only those currently being implemented in the identified year) and by region between 2016 (n = 210), 2017 (n = 252), 2018 (n = 277) and 2019 (n = 130).

*Note.* Ratings ranged from "0," or "does not currently implement the policy or practice item," to "5," or "yes, implementing 100% of the time." Additional ratings include: "1" = implementing up to 24% of the time; "2" = implementing between 25-49% of the time; "3" = implementing between 50-74% of the time; and "4" = implementing between 75-100% of the time.



*Figure 1.* Change in average *Concussion BINGO* scores by location 2016-2019 (includes only those policies that were being implemented, ratings 1-5)

Figure 1 key findings include:

- Of those policies / practices that were being implemented in the identified year, the overall average rating statewide *Concussion BINGO* for 2016, 2017, 2018 and 2019 was 3.9, or implementing between 50 and 75% of the time. This rating improved to 4.2 for 2019.
- Overall *Concussion BINGO* ratings remained relatively stable from 2016 to 2019 for the Columbia region. Ratings for the Kansas City and St. Louis regions show a steady improvement from 2016 to 2019.
- ★ Attendees of the seminars in the Kansas City region gave the lowest average ratings in 2016 (M = 3.4), however ratings increased in 2017, 2018 and 2019 (2017: M = 3.6, 2018: M = 4.0 and 2019: M=4.1).

Table 3 displays the number and percentage of respondents who reported that the organization that they represent implements the identified policy or practice. Table 3 also shows the average Concussion BINGO item ratings in 2019.

Table 3 key findings include:

- 90% of respondents reported that the following concussion management practices were being implemented within their school or team in 2019: "emergency action plan" (91.6%), "coach's education" (91.5%), and "adequately using resources" (90.0%).
- Fewer than 50% of respondents reported that the following concussion management practices were being implemented within their school or team in 2019: "school board meeting and education" (47.7%) "team doctor" (46.9%), and "ambulance at all contests" (36.9%).
- ✤ Of those policies that were being implemented in 2019, the highest average item rating statewide in 2019 was for "pre-participation on physical evaluation form" (*M* = 4.8). [*Note*. A rating of "4" = implementing the policy or practice between 75-100% of the time].
- On average, respondents reported that all but one policy or practice item ("ambulance at all contests") are implemented at least 50% of the time in 2019 (with a rating of "3" or higher).

Table 4 shows the number and percentage of respondents who reported that the organization that they represent implements the identified policy or practice by region. Table 4 also shows the average Concussion BINGO item ratings in 2019 by region. In general, the percentage of organizations implementing each policy or procedure varies greatly by region. For example, only 34% of respondents from Columbia reported that their organization has a "Certified Athletic Trainer (full-time)," whereas 81.6% and 76.2% of respondents from Kansas City and St. Louis responded affirmatively to this item, respectively.
