### Position Had to be Filled More Than Once in Past 12 Months





**Agency Contributes Financially (fully or partially) to Following Benefits for Employees**





### How Satisfied Agency is with Technical Assistance and Services Provided by DHSS - Statewide





### How Satisfied Agency is with Technical Assistance and Services Provided by DHSS - Agencies 0-9,999 Population










**How Satisfied Agency is with Technical Assistance and Services Provided by DHSS -


**Utilization of Volunteers  
Agencies 10,000 to 24,999 Population**




**Utilization of Volunteers

Agencies 50,000 to 99,999 Population**


