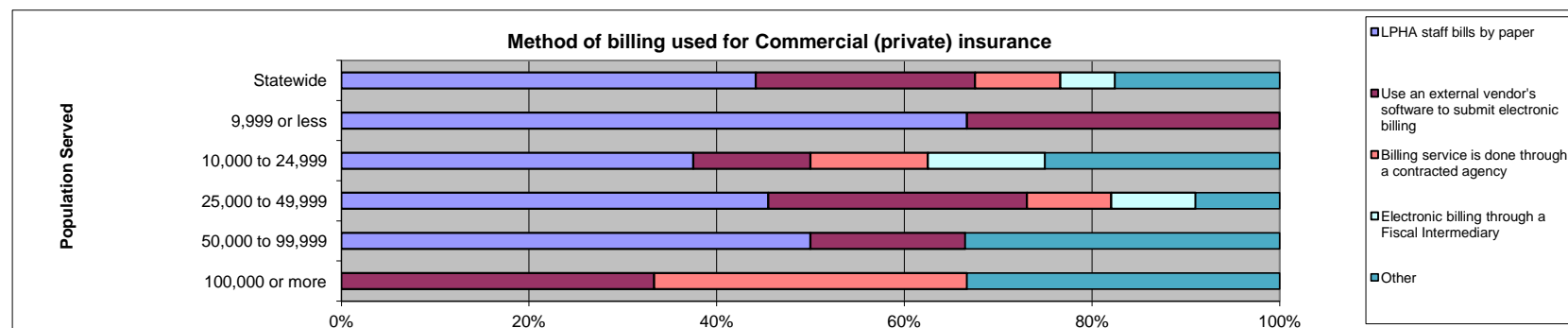

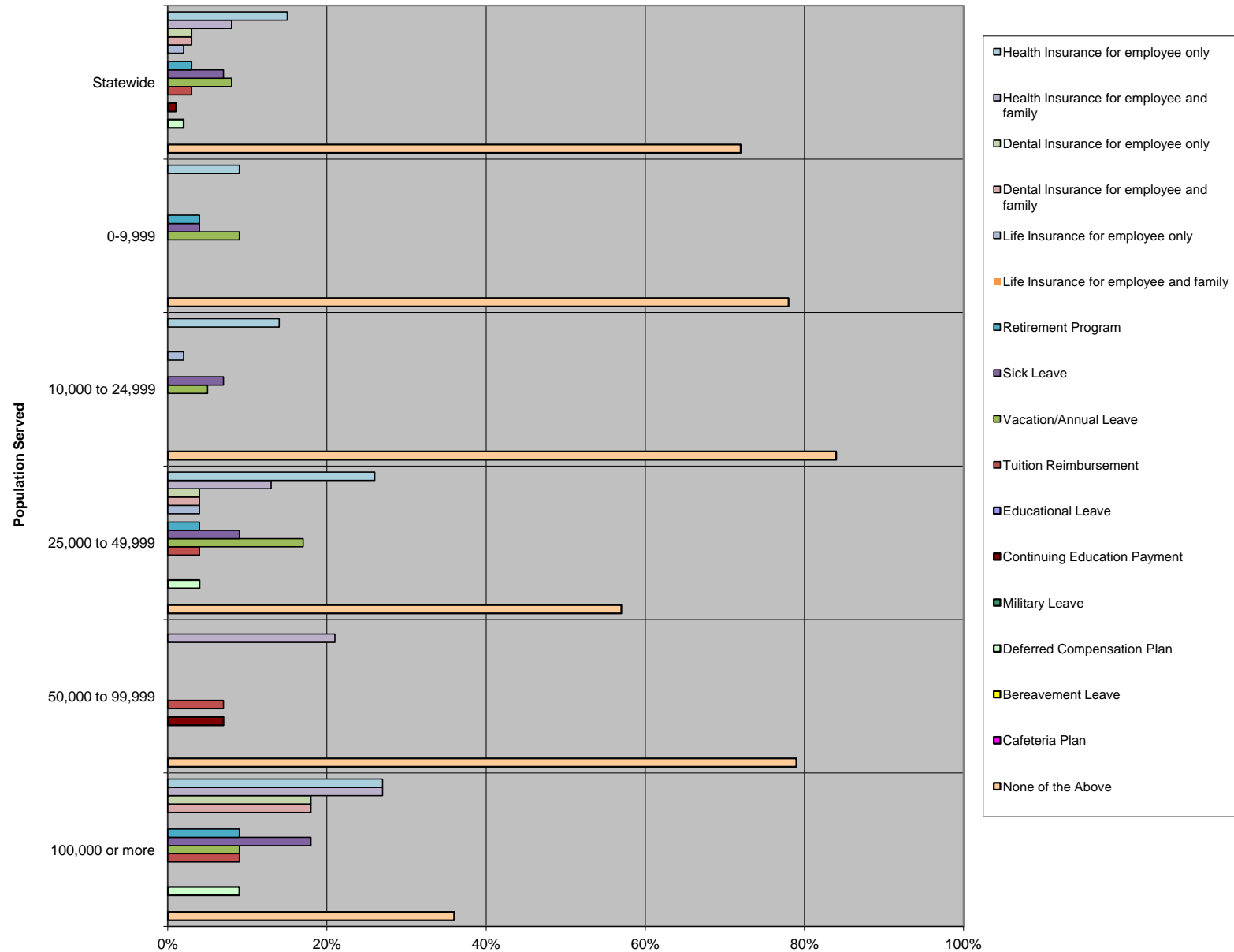

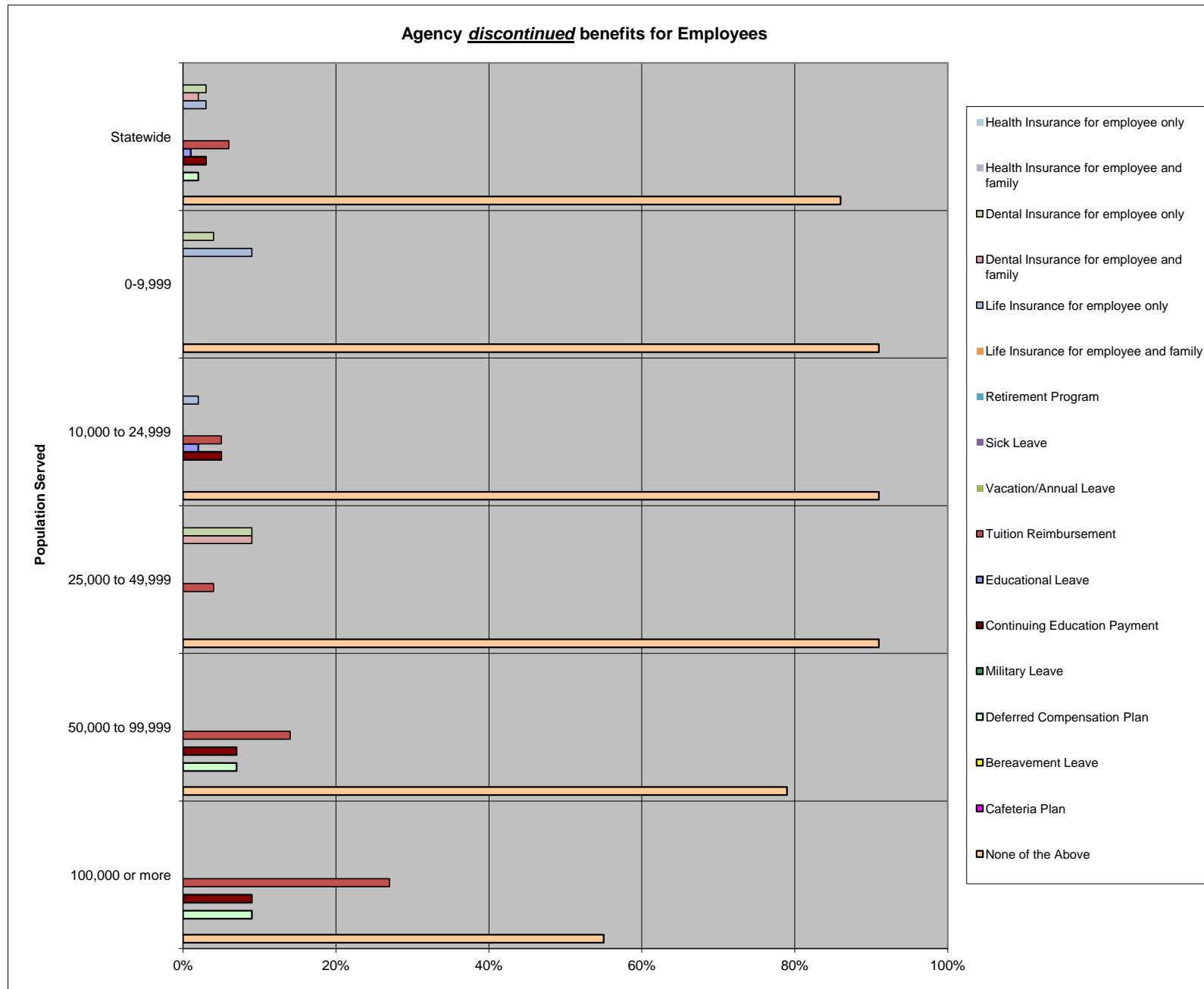
Agency reduced benefits for Employees
