

# Researching an EHR Company

- Make a list of desired functionality before beginning the research process. Even if the software doesn't offer a certain feature, you will have a basis of comparison for other solutions. This is your "Needs and Wants" list.
- Check the Office of the National Coordinator (ONC) certification status of the EHR technology. Even if you are not interested in attesting for Meaningful Use incentives, the certification website is a valuable resource for learning about what certain EHR software options offer.

## Checking the ONC Certification List

Navigate to <https://chpl.healthit.gov/#/search> and search for the EHR software and version in which you are interested.
