

BUREAU OF EMS EMT-PARAMEDIC RELICENSURE GUIDELINES

Relicensure is once every five years upon completion and verification of required continuing education and submission of the relicensure application.

To renew license, the applicant must:

1. Complete the application and return it with the proper documentation to the Unit of Emergency Medical Services. The Unit of EMS reserves the right to investigate relicensure materials at any time from any applicant. Applicants may be required to resubmit all materials upon written notice from EMS.
2. **BE CURRENTLY CERTIFIED BY THE NATIONAL REGISTRY OF EMTS**
OR
3. Complete all continuing education requirements prior to his/her expiration date.

Current CPR Certification (regardless of teaching agency all CPR training must adhere to AHA or American Red Cross or National Safety Council Standards).</p> <p>C. Current certification – “Advanced Cardiac Life Support” 16 hours.</p>	<p>The 96-hour training must follow the topical listing in Appendix A of the DOT EMT-Paramedic Refresher Training Program (see Core Requirements).</p> <p>CPR course must be completed within the remaining two years of the licensure period. <p>Section II</p> <p>Additional 48 hours of Continuing Education.</p> <p>50% of total (24 hours) will be accepted in one topic.</p> <p>Successful completion of any of the following National Standard Courses may be applied towards Section II: Emergency Driving Emergency Medical Dispatcher Training</p>	<p>In addition to the topics listed below, any subject covered in the National Standard Paramedic Curriculum will be accepted.
