Grant Specific Term(s)

1. This revised Notice of Award is issued to deobligate the sum of \$3,795,472 from old document number (20X10MC39696) and will reobligate the funds under the new document number (20X10MC45193) to change the grantee organization from the Missouri Department of Health Senior Services to the Missouri Department of Elementary and Secondary Education in accordance with the transfer prior approval request (PA-00099465) submitted by Brian Bishop on 8/31/21.
2. The document number referenced has expired and is closed in the Payment Management System. The closeout of this grant does not automatically cancel any requirements for property accountability, record retention, or financial accountability. Recipients must continue to track all equipment and supplies acquired under the award after grant closeout in accordance with the property management requirements of 45 CFR Part 75, as applicable. The recipient must request disposition instructions from HRSA for any property that is no longer needed. Any real property acquired with DHHS grant support may not be conveyed, transferred, assigned, mortgaged, or in any other manner encumbered by the grantee, except as expressly authorized in writing by the DHHS awarding component or its successor organization. The Government's interest in real property acquired under grants is described in 45 CFR Part 75.
