The above-referenced expedited Certificate of Need (CON) application has been received. We also acknowledge receipt of the application fee in the amount of **\$1,000**. Application fees are deposited in the state treasury upon receipt and cannot be refunded. With the receipt of the application and fee, the review cycle for this project began on **5/16/2025**.

Upon review of the CON application for 6211 RT, the 90% average occupancy requirement for the previous six quarters of licensed beds has not been met as required by statute 197.318.4(1)(b)b to purchase beds from another facility.

Below are your options of what to do with the #6211 RT Mason Pointe CON application:

19 CSR 60-50.420 (7):

- (C) For expedited applications **which do not meet all statutory and rules requirements** or those which have opposition, they will be considered at the earliest scheduled committee meeting where the written analysis by the CONP staff can be sent to the committee and the applicant at least seven (7) days in advance. **(This would be placed on the July 14 CON Meeting agenda)**
- (9) An applicant may withdraw an application without prejudice by written notice by mail or email at any time prior to the committee's decision. Later submission of the same application or an amended application shall be handled as a new application with a new fee.
