### **Terms and Conditions**

1. Administration for Strategic Preparedness and Response (ASPR) Fiscal Year (FY) 2024 Hospital Preparedness Program (HPP) Administrative Supplement for H5N1 Avian Flu Additional Funds

The U.S. Department of Health and Human Services provided additional funds to ASPR to support the preparedness and response needs of the health delivery system for emerging special pathogen threats, such as avian influenza or bird flu. As part of this additional funding, \$90,300,000 will be used for existing and new activities to increase the capability of HPP recipients and health care coalitions (HCCs) to bolster preparedness and response activities for emerging threats, including avian influenza.

Please note, every jurisdiction is different and must tailor their activities to meet the needs of their communities and achieve the outcomes. While there may be differences between and among jurisdictions, all may be called upon during large scale emergencies to contribute to a shared responsibility of national preparedness and response. HPP recipients and their HCC(s) must work together to identify and meet community needs, foster connections among members, and strengthen the health care delivery system's capability and capacity to continue to provide care during a disaster or emergency, improve patient outcomes, save lives, and protect the health care workforce. This includes strengthening the health care delivery system's ability to prepare for and respond to all-hazards and emerging threats, including avian influenza.

Please provide a work plan, detailed budget, and budget narrative/justification within 60 days of the award to address the following activities:

- · Establish Governance: Recipients will work with their HCC(s) to review and, as needed, update governance documents for their coalitions to bolster readiness for emerging threats, such as avian influenza. This may include updating governance documents to describe: any new management or administration updates; coordination with Regional Emerging Special Pathogen Treatment Centers (RESPTCs) or other components of the National Special Pathogen System (NSPS); policies and procedures for response operations; and other updates as needed.
- Assess Readiness: Recipients will work with their HCC(s) to review and, as needed, update assessments for their coalitions to identify threats, risks, hazards, vulnerabilities, and needs, including considering the specific needs and risks of communities with higher risk for an avian influenza outbreak (e.g., rural areas, areas in close proximity to agriculture). These updates may include identifying potential supply chain needs and vulnerabilities (e.g., personal protective equipment) or workforce shortfalls as a result of emerging threats, such as avian influenza.
- Plan and Implement: As appropriate, recipients will work with their HCC(s) to update plans to address preparedness, response, and recovery for emerging threats such as avian influenza. This may include updating information-sharing plans, resource management plans (e.g., supplemental staffing and personal protective equipment [PPE] stockpile activation and deployment), patient movement plans (e.g., coordination with RESPTCs), and training and exercise plans (e.g., using training resources developed by the National Emerging Special Pathogens Training and Education Center [NETEC] or RESPTCs) to support readiness for emerging threats. Recipients and HCCs will coordinate with RESPTC(s) in their region to update the Special Pathogen Annex to their medical surge plan, incorporating considerations for avian influenza.
  - Please note: Patient movement planning includes coordination with emergency medical services (EMS). The term EMS will encompass pre-hospital care including ambulance services, paramedic services, and 911 dispatch, as well as specialty transport, including pediatric transport, air transport, and critical care transport. Recipients and their HCC(s) must

work with HCC members and additional health care readiness partners (e.g., Biosafety Transport Consortium, other partners that support EMS readiness) to review and update plans as needed, particularly to incorporate considerations for avian influenza.

Exercise and Improve: As appropriate, recipients will work with their HCC(s) to conduct exercises related to medical surge, patient movement, and additional jurisdictional priorities or areas of improvement. As appropriate, this should include a health care preparedness exercise that specifically addresses the needs of communities most impacted by the avian influenza outbreak (e.g., rural communities, communities in close proximity to agriculture).
