**PURPOSE: Correction to Award:** This revised Notice of Award is to administratively correct the approved funding for Year 04 budget period. The approved funding for this award should read **\$1,771,670** instead of **\$1,851,789** for the Budget Period **01/01/2017** through **12/31/2017**. Any questions pertaining to the change in approved funding please contact your assigned Project Officer.

**Incremental Funding:** This revised Notice of Award is to award incremental funding in the amount of **\$ 843,956**. Previously, **\$ 870,117** had been awarded, in addition to the unobligated funds making the current total available award amount **\$1,771,670** of the approved **\$1,771,670** for the Year **04** budget period which is **01/01/2017** through **12/31/2017**.

**This award has been fully funded for budget year 04.**

**Use of Unobligated Funds:** This NOFO includes use of Year **2015** unobligated funds in the amount of **\$ 57,597**, which has been applied as an offset to the currently approved funding level for this budget period. The use of unobligated funds is approved based on the Year **2015** Federal Financial Report (FFR) dated **August 19, 2016**. The amount of this NoA will be subject to reduction if the final amount of unobligated funds is less than the amount of unobligated funds reported on the referenced FFR.

**Budget Revision Requirement:** By **September 7, 2017** the grantee must submit a revised budget with a narrative justification and work plan. Failure to submit the required information in a timely manner may adversely affect the future funding of this project. If the information cannot be provided by the due date, you are required to contact the GMS/GMO identified in the Staff Contacts section of this notice before the due date.

All the other terms and conditions issued with the original award remain in effect throughout the budget period unless otherwise changed, in writing, by the Grants Management Officer.
