SUMMARY STATEMENT: The purpose of this revised Notice of Award (NOA) is to respond to your letter submitted August 29, 2017, which provided responses to the Summary Statement. This request has been reviewed and approved.

REVISED BUDGET: The purpose of this revised Notice of Award (NOA) is to respond to your letter submitted August 29, 2017. Your request has been approved as follows:

- Salaries and wages have increased from \$129,378 to \$236,784
- Fringe has increased from \$64,451 to \$122,768
- Supplies have decreased from \$29,616 to \$17,751
- Contractual costs have decreased from \$190,000 to \$90,613
- Travel costs have decreased from \$102,701 to \$42,348
- Other costs have decreased from \$38,110 to \$14,125
- Indirect costs have increased from \$45,744 to \$75,611
