My name is Justin Brown, I am of sound mind, capable of making this affidavit, and personally acquainted with the facts herein stated:

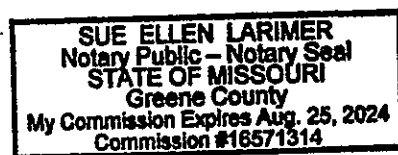
