Encounter Ministry is extremely grateful for the experience of the program this year. Participating in the Rural Non-Congregate Option, we far surpassed last year's distribution. We did this while building community relationships, and friendships.

Encounter Ministries Rural Non-Congregate Meal Pick-Up Process

Our Process began with each family registering for the meal pick-up.

- 1. Automated by Poster with JotForm QR Code.
- 2. English and Spanish Registration Form
- 3. Family Letter with Refrigerator Magnet Every family got an initial welcome letter and refrigerator magnet.





Communication Is Key

- 1. Text message reminders to families permission to send text messages. Sent every week before distribution.
- 2. Rosters-Site Managers received a weekly current roster of all registered families and children.
- 3. Allergy list separated for individual preparation.

Encounter Ministries Meal Preparation and Distribution

Preparation

- 1. We employed paid workers from school, some volunteers.
- 2. Controlled inventory set up stations with assembly counts
- 3. Every bag was counted when built.
- 4. Food kept in a refrigerated truck.
- 5. Final inventory sent back to sponsor.

Distribution

- 1. Placards were used for each registered family for their dashboards Name, Number of Children, Allergies. This made identification easier.
- 2. Gave Rosters to workers to cross check names and counts.
- 3. Two distribution lines used to expedite distribution.
- 4. Dedicated counters and loggers. Two factor count & ID used.
- 5. Tally triple checked with roster and log form and counter
