Virtual Transfers

19 CSR 100-1.130(1)(M) requires licensees ensure the accuracy of information entered into the state-wide track and trace system, but sometimes errors occur, and we need to take measures to correct them. One of these measures is a Virtual Transfer.


Virtual Transfer Example:

A dispensary accepted a package with quantity of 20 each during intake, but only physically received 10 each. The dispensary would need to request a virtual transfer to return the 10 to the originating license, to reflect the amount received in physical inventory.

Transfers Hub

Per 19 CSR 100-1.140(2)(D), Each licensee involved in a transfer is responsible for accurate inventory information:

- Originating licensees are responsible for the initial inventory and manifest
- Transporting licensees must compare inventory and manifest before accepting for transport
- Receiving licensees must:
 - Compare inventory and manifest before accepting
 - Reject and return packages that differ from the manifest
