SUBJECT: DMH and HCY Service Coordination Policies Updates

The Home and Community Based Services (HCBS) Policy Manual has been updated to reflect revisions to the Department of Mental Health (DMH) Service Coordination and Healthy Children and Youth (HCY) Coordination policies as outlined below.

Additionally, this serves as a reminder that participants may not be enrolled in more than one self-direction program or one waiver at a time. Division of Senior and Disability Services (DSDS) staff shall coordinate with the Division of Developmental Disabilities (DD) support coordinator so participants who qualify for State Plan CDS and waivers through the DD programs are aware of their options and to prevent duplication of services.
