SUBJECT: Policy Updates for the Provision of the HCBS Quality Measure Set

The updates to the Home and Community Based Services (HCBS) policy manual are based on the Centers for Medicare & Medicaid Services (CMS) Access rule. The rule mandates new requirements, which include the HCBS Quality Measure Set. The following policies have been updated to ensure compliance with all applicable requirements.

- List the name and contact information for key individuals involved in the care planning process and add relevant information in the "Contact Notes"
- List the name and phone number of the participant's primary care physician.

The Rights and Responsibilities have been revised to include two website links to assist with locating a primary care physician and with resources for mental health or substance abuse.
