Subject: Structured Family Caregiving Waiver

This memorandum is to notify Home and Community Based Services (HCBS) staff and stakeholders of the newly funded Medicaid waiver: Structured Family Caregiving Waiver (SFCW).

Prospective providers must enroll as a Type 26 provider with Missouri Medicaid Audit and Compliance (MMAC), and complete the Structured Family Caregiving Waiver addendum and fax to Missouri Medicaid Audit and Compliance (MMAC) Provider Enrollment at 573-634-3105.
