SUBJECT: Service Reimbursement Rates (Correction)

The Division of Senior and Disability Services (DSDS) is issuing a correction to Provider Memo PM-14-16 and Vendor Memo VM-14-17 dated June 25, 2014. The amount of the Personal Care Assistance under the Independent Living Waiver Services heading was listed incorrectly. The correct amount is listed in the chart below. In addition, the monthly limits for Personal Care Assistance - Consumer Directed Model under the State Plan Services heading has been corrected. All other information is correct. DSDS regrets any inconvenience this may have caused.

Effective July 1, 2014 for Fiscal Year 15 (FY15), the reimbursement rates for MO HealthNet fee-for-service Home and Community Based Services (HCBS) will be as listed in the chart below.

This will affect services provided under the In-Home Services (IHS) programs as well as the Consumer-Directed Services (CDS) programs.

There is no change in the reimbursement rate for Case Management, Specialized Medical Equipment, Specialized Medical Supplies, and Specialized Medical Adaptations through the ILW.
