SUBJECT: Consumer Directed Services Reporting Revisions

The Missouri Medicaid Audit and Compliance Unit ("MMAC") is the unit within the Missouri Department of Social Services ("DSS"), the single state agency responsible for the administration of the Medicaid Title XIX program in Missouri, charged with administering and managing Medicaid Title XIX audit and compliance initiatives and provider contracts under the Medicaid Title XIX program. One of MMAC's responsibilities, as directed by the DSS, is to perform the functions and operations formerly under the Department of Health and Senior Services ("DHSS"), HCS Provider Contracts, which includes monitoring proposals and contracts in Missouri in accordance with any and all applicable federal and state laws and regulations.

In order to comply with provisions of 19 CSR 15-8.400 (7)(G) & (H) and the Independent Living Waiver, Vendors must complete and submit the Quarterly Financial Report and Quarterly Service Report for Consumer Directed Services.
