Executive Summary

Survey Background and Methods

In 2024, the State of Missouri Department of Health and Human Services in partnership with the Missouri Association of Area Agencies on Aging (MA4) contracted with Polco to implement a needs assessment survey with a representative sample of older adult residents to inform decision making and Missouri's Master Plan on Aging. In addition, they wished to gather information from adults (age 18 and older) with disabilities and from adult (age 18 and older) caregivers.

A total of 158,489 Missouri households were selected to participate in the survey; about half of these were randomly selected from households believed to have a member aged 50 or older, and half were randomly selected from all households. These survey recipients were contacted by mail two times with a postcard notifying residents that they had been chosen to participate in the survey and providing them the option to complete the survey online or to request a paper survey, complete the survey over the phone with an interviewer, or request an in-person interview. Additionally, responses were collected through openparticipation outreach promoted by the State of Missouri and local Area Agencies on Aging.

Overall, the State of Missouri gathered opinions from 7,621 respondents: 6,842 were older adults (50+), 2,612 were residents with disabilities (18+), 2,326 were caregivers (18+), and 290 did not fall into any of those categories (residents were able to multi-select options, so some residents fall into multiple categories). The results of those who identified as older adults were weighted to reflect the demographic profile of all residents in the State.

Key Findings

Current and Future Caregivers

- Current caregivers indicated that they have some significant needs regarding support. About two-thirds of Missouri caregivers somewhat or strongly agreed that they need help locating services for the people they care for. Additionally, nearly 6 in 10 residents somewhat or strongly agreed that they need temporary relief from their caregiver duties and need help paying for services needed by the person they care for. Just under half of caregivers also indicated they would like training on caring for someone at home.
- Future caregivers reiterated similar needs as current caregivers. Nearly 8 in 10 respondents indicated they anticipate needing help locating services for the person they will care for. About 7 in 10 respondents felt they would need help paying for services needed by the person they plan to care for, and two-thirds shared they would require temporary relief from caregiver duties.

Employment Status and Challenges

- Caregivers faced the most employment challenges of all three respondent types with 2 in 10 respondents facing difficulty finding a job that paid enough. While close to 1 in 10 struggled to find a job that matched their skills, find a job close to their home, were unable to leave the individual they were caring for alone in order to work, and had concerns about losing public benefits.
- Around 1 in 10 older adults indicated struggling to find a job that paid enough.
- About 1 in 10 adults with disabilities struggled to find a job that matched their skills, a job that paid enough, and indicated concern about losing public benefits.

Housing and Accessibility

- Around two-thirds of residents across respondent type positively rated the availability of parks that they feel safe visiting, and parks that are accessible to them. In contrast, only around one-third of residents indicated that their communities had a place for people to live as they age, indicating a potential area of focus.
- Many respondents across the state indicated that their residence was in need of repair to improve their ability to live safely, including nearly 4 in 10 people with disabilities, close to 3 in 10 older adults, and one-third of caregivers.

Transportation

- Nearly 9 in 10 older adults and caregivers have access to a personal vehicle as their main form of transportation, while just over 8 in 10 residents with disabilities indicated they have regular access to a personal vehicle. Relatedly, nearly 4 in 10 older adults and caregivers have regular access to rides from friends of family, while nearly half of adults with disabilities have access to rides from friends and family.
- Most survey respondents (about two-thirds or higher) indicated that they do not have access to trolley/streetcars, metro/train, public use bicycles, scooters, Paratransit, or bus services in their communities.
- Nearly two in ten adults with disabilities indicated that they faced the following barriers in accessing transportation in the past 12 months: they didn't know what transportation services are available in my community, transportation services didn't go where they needed them, and/or the cost of transportation was too high.

Technology and Information Resources

- Over 8 in 10 of all respondents indicated they have a smart phone (call, text, and internet), while 2 in 10 indicated they have a mobile phone (call and text only) or a landline phone. Similarly, over 8 in 10 of all respondents indicated they have access to high-speed internet/broadband at home.
- Of those who do not have high-speed internet/broadband at home, around 50% indicated they cannot afford high-speed internet. Closer to 3 in 10 reported that high-speed internet is not available in their area, and close to 2 in 10 said they were not interested in high-speed internet.
- The most favored modes of communication among residents were email (preferred by 8 in 10 respondents), text (preferred by 7 in 10 respondents), website updates (preferred by 6 in 10 respondents), and brochures (preferred by 5 in 10 respondents).
- At least 3 in 10 residents across respondent type indicated they had challenges knowing what services are available to older adults in their community, knowing what services are available to people with disabilities in their community, and having adequate information on dealing with public programs such as Social Security, Medicare, and Medicaid.

Whole-Person Health

- Just over one-third of adults with disabilities indicated that having opportunities to socialize and meet new people was a moderate or minor problem for them. A similar proportion of adults with disabilities indicated that feeling depressed was a challenge for them.
- Close to 8 in 10 residents reported that they know how to report abuse, neglect, or exploitation of themselves or others.
- Adults with disabilities faced the most challenges related to independent living, with over half indicating that staying physically fit, doing heavy or intense housework, and maintaining their home were moderate or major problems.
- Just over half of respondents with disabilities experienced one or more falls in the last 12 months, compared to just over 3 in 10 caregivers and older adults.
- Close to 3 in 10 of all respondent types were unable to access healthcare they needed in the past 12 months with the most notable barriers (close to 10%) being the cost to access healthcare was too high and being unable to find a provider in their area that provides the healthcare they need.
- At least 3 in 10 of all respondent types always or frequently experienced not having enough money available to eat balanced meals. While 50% or more of all respondents had awareness of food assistance programs, 30% or less reported using those programs.

Survey Background

Survey Purpose

In 2024, the State of Missouri Department of Health and Human Services in partnership with the Missouri Association of Area Agencies on Aging (MA4) contracted with Polco to implement a needs assessment survey with a representative sample of older adult residents to inform decision making and Missouri's Master Plan on Aging. In addition, they wished to gather information from adults (age 18 and older) with disabilities and from adult (age 18 and older) caregivers.

The Area Agencies on Aging in Missouri partnered with the State on this effort to ensure they all received reports specific to their AAA service areas so that they could use the data gathered to make data driven decisions in their service areas and better support their residents.

Survey Administration

A total of 158,489 Missouri households were selected to participate in the survey; about half of these were randomly selected from households believed to have a member aged 50 or older, and half were randomly selected from all households. These survey recipients were contacted by mail two times with a postcard notifying residents that they had been chosen to participate in the survey and providing them the option to complete the survey online or to request a paper survey, complete the survey over the phone with an interviewer, or request an in-person interview. A total of 3,858 people completed the survey, providing an overall response rate of 2.4%. Of the 3,858 completed surveys, 2,962 were completed online, 22 were completed via phone interview, and 874 on paper.

Responses were also collected through open-participation outreach promoted by the State of Missouri and local Area Agencies on Aging. A total of 3,763 residents responded to this outreach effort.

The survey was available in Spanish, French, German, Arabic, and Simplified Chinese and all mailings contained instructions in those languages on how to access the online survey.

Overall, the State of Missouri gathered opinions from 7,621 respondents: 6,842 were older adults (50+), 2,612 were residents with disabilities (18+), 2,326 were caregivers (18+), and 290 did not fall into any of those categories (residents were able to multi-select options, so some residents fall into multiple categories). The results of those who identified as older adults were weighted to reflect the demographic profile of all residents in the State.

It is customary to describe the precision of estimates made from surveys by a "level of confidence" and accompanying "confidence interval" (or margin of error). The 95 percent confidence interval for this survey is generally no greater than plus or minus 2% around

any given percent reported for all survey respondents (3,858). For comparisons among subgroups, the margin of error rises.

How the Results are Reported

For the most part, frequency distributions and the "percent positive" are presented in the body of the report. The percent positive is the combination of the top two most positive response options (i.e., "excellent" and "good," "strongly agree" and "somewhat agree"). For the questions about challenges faced by respondents, we show the proportion who said each was a "major" or "moderate problem."

On many of the questions in the survey, respondents could give an answer of "don't know." The proportion of respondents giving this reply is shown in the full set of responses included in the appendices. However, these responses have been removed from the analyses presented in the body of the report, unless otherwise indicated. In other words, the majority of the figures in the body of the report display the responses from respondents who had an opinion about a specific item.

When a figure for a question that only permitted a single response does not total to exactly 100%, it is due to the common practice of percentages being rounded to the nearest whole number.

Comparing Survey Results by Geographic and Demographic Subgroups



Survey Results

Survey Participants

The State of Missouri wanted to hear from three types of residents: older adults (age 50 or older), adults with disabilities (age 18 or older), and adults who were caregivers (age 18 and older). Many residents fit into more than one of these categories. The figures below cover respondent type and show further participant breakdowns by older adults, adults with disabilities, and caregivers. *(Note: Figures 1-8 relate to survey participants).*



Figure 3: Age of Adults with Disabilities




Figure 4: Disability Type






Figure 5: Age of Caregivers

Figure 6: Types of Caregiving





What is your relationship to those for whom you provide care? (If caring for more than one individual, select each relevant option.)*



Percent who expect to provide care or assistance to a friend or family member who has a health problem or disability in the next two years





Figure 12: Anticipated Needed Supports for Future Caregivers

Housing and Accessibility





Whole-Person Health

Whole-Person Health poses the greatest risk and the biggest opportunity for communities to ensure the independence and contributions of their older adults, adults with disabilities, and caregivers. Whole-Person Health, for the purposes of this study, included not only physical and mental health, but broader topics like issues of safety, independent living, inclusion, employment, and finances.

The individual survey questions about specific problems faced by respondents were broken into categories to provide a broader picture of needs for older adults, adults with disabilities, and caregivers in Missouri. The figures below show the percent of respondents who reported that one or more items was a major or moderate problem in the categories of: Inclusion and Productivity, Safety, Independent Living, Falls, Access to Healthcare and Medication, Food Access, and End of Life Document Preparation. *(Note: Figures 32-54 relate to whole-person health).*






Figure 40: Number of Falls in Last 12 Months




Figure 43: Barriers to Accessing Healthcare



Figure 46: Percent of Respondents Who Do Not Have Health Insurance






Figure 47: Health Insurance Coverage




Figure 49: Inability to Afford Medications

Percent of respondents who have no estate planning/advance directive documents




Figure 54: End of Life Document Preparation

Appendix E. Survey Methodology

Survey Purpose

In 2024, the State of Missouri Department of Health and Human Services in partnership with the Missouri Association of Area Agencies on Aging (MA4) contracted with Polco to implement a needs assessment survey with a representative sample of older adult residents to inform decision making and Missouri's Master Plan on Aging. In addition, they wished to gather information from adults (age 18 and older) with disabilities and from adult (age 18 and older) caregivers.

The Area Agencies on Aging in Missouri partnered with the State on this effort to ensure they all received reports specific to their AAA service areas so that they could use the data gathered to make data driven decisions in their service areas and better support their residents.

Developing the Questionnaire

The 2024 Missouri Needs Assessment survey questionnaire was developed by starting with the version that the State had used previously. Through an iterative process between the State of Missouri staff and Polco staff, a final eight-page questionnaire was developed. This research was funded by the State of Missouri.

Selecting Survey Recipients

In order to hear from a representative group of the target population for this survey, households were randomly selected to receive the survey invitation. As one of the primary purposes of the survey was to hear from older adults age 50+ in Missouri, half of the households selected to receive the survey invitation were those believed to include at least one older adult member. This mailing list was purchased Marketing Systems Group who uses propriety methods and resources to identify these households. A total of 78,338 older adult addresses were selected from within each County in Missouri.

To target caregivers and adults with disabilities, the other half of selected survey recipients came from a list of all households within the State, also purchased from Marketing Systems Group, using updated listings from the United States Postal Service's Delivery Sequence File. A random selection 80,151 addresses was made within each County; these addresses were "de-duped" against the older adult list to make sure that no household was selected twice.

Multiple individuals within each household who met the survey criteria were able to complete the survey. The survey was available in Spanish, French, German, Arabic, and

Simplified Chinese and all mailings contained instructions in those languages on how to access the online survey.

In addition to the invitations sent to this probability-based (random sample) list, a link to an online "open participation" survey was publicized through various channels. This open participation questionnaire was identical to that sent to the probability-based list, and open to all residents of Missouri. The open participation survey was also available in Spanish, French, German, Arabic, and Simplified Chinese.

Survey Administration and Response

The 158,489 randomly selected households were contacted twice through mailed outreach. All mailed materials were co-branded with State logos and signatories, and AAA logos and signatories. First, an invitation postcard informing the household members that they had been selected to participate in the State of Missouri Needs Assessment Survey was sent on June 13, 2024. The postcard included a URL and QR code to take the survey online. It also provided a phone number where residents could call to request a paper survey, complete the survey over the phone, or request an in-person interview. Approximately one week after mailing the initial postcard, these households were mailed a reminder postcard enlisting participation. The reminder postcard asked those who had not completed the survey to do so and included the URL and QR code for the online response option. It, again, provided a phone number where residents could call to request a paper survey, complete the survey over the phone, or request an in-person interview. Completed surveys were collected over the following thirteen weeks.

Generally, about 2% of postcards mailed are returned because the housing unit was vacant, or the postal service was unable to deliver the survey as addressed. Of the remaining 155,320 households estimated to have received the survey, 3,858 completed the survey, providing an overall response rate of 2.4%. Of the 3,858 completed surveys, 2,962 were completed online, 22 were completed via phone interview, and 874 on paper. The response rates were calculated using AAPOR's response rate #2¹ for mailed surveys of unnamed persons.

The online open participation survey became available to all residents on July 8, 2024, and remained open for ten weeks. A total of 3,763 residents responded to this outreach effort. The data from the "open participation" outreach effort was blended with the random sample dataset after making statistical adjustments based on how different the datasets were.

The 95% confidence interval (or "margin of error") quantifies the "sampling error" or precision of the estimates made from the survey results. A 95% confidence interval can be calculated for any sample size and indicates that in 95 of 100 surveys conducted like this one, for a particular item, a result would be found that is within three percentage points of

the result that would be found if everyone in the population of interest was surveyed. The practical difficulties of conducting any resident survey may introduce other sources of error in addition to sampling error. Despite best efforts to boost participation and ensure potential inclusion of all households, some selected households will decline participation in the survey (referred to as non-response error) and some eligible households may be unintentionally excluded from the listed sources for the sample (referred to as coverage error).

While the margin of error for the survey is generally no greater than plus or minus 2 percentage points around any given percent reported for all 3,858 respondents, results for subgroups will have wider confidence intervals. Where estimates are given for subgroups, they are less precise and statistical differences between subgroups are noted in the tables in the Appendices.

The table below shows the number and proportion of respondents who fell into each of the three target groups. Of course, respondents could identify in more than one category, so these percents add to more than 100%. About 90% of all the respondents identified as an older adult.

Survey Processing (Data Entry)

Mailed surveys were returned via postage-paid business reply envelopes. Once received, staff assigned a unique identification number to each questionnaire. Additionally, each survey is reviewed and "cleaned" as necessary. For example, a question may have asked a respondent to pick two items out of a list of five, but the respondent checked three; staff would choose randomly two of the three selected items to be coded in the dataset.

Once all surveys were assigned a unique identification number, they were entered into an electronic dataset. This dataset is subject to a data entry protocol of "key and verify," in which survey data were entered twice into an electronic dataset and then compared. Discrepancies were evaluated against the original survey form and corrected. Range checks as well as other forms of quality control were also performed.

Polco used its own platform to collect online and phone survey data. Use of an online system means all collected data are entered into the dataset when the respondents submit the surveys. Skip patterns or logic are programmed into the system, so respondents are automatically "skipped" to the appropriate question based on the individual responses being given. Online programming also allows for more rigid control of the data format, making extensive data cleaning unnecessary.

A series of quality control checks were also performed in order to ensure the integrity of the web data. Steps may include and not be limited to reviewing the data for clusters of repeat IP addresses and time stamps (indicating duplicate responses) and removing empty submissions (questionnaires submitted with no questions answered).

Weighting the Data

Statistically adjusting the relative "weight" given to different demographic subgroups is a survey research best practice to ensure the responses from survey respondents are reflective of the target population. However, for this needs assessment, only 10% of respondents were not older adults, and there are no known population norms for the demographic characteristics of caregivers. So weighting was only applied to the older adults; respondents who were not age 50 or more were all assigned a weight of one.

The demographic characteristics of the older adult survey respondents were compared to those found in the 2022 American Community Survey (ACS) 5-year estimates. Survey results were weighted using the population norms to reflect the appropriate percentage of those residents in the State. Other discrepancies between the whole population and the sample were also aided by the weighting due to the intercorrelation of many socioeconomic characteristics. The results of the weighting scheme are presented in table below.
