




Dr. Jacqueline Miller, DDS, MS, MPH

Dr. Miller was named the Missouri State Dental Director in August 2022. She practiced orthodontics for nearly 30 years in Washington, Missouri. Dr. Miller has served in multiple leadership positions in the American Association of Orthodontists and was the first woman to hold the office of President of the Midwestern Society of Orthodontists. She has an extensive career of leadership, advocacy for dentistry and volunteerism both in Missouri and abroad. Dr. Miller has made 25 dental mission trips and participated in Give Kids a Smile and Missouri Mission of Mercy.

As the Missouri State Dental Director, Dr. Miller is promoting an increase in the Preventive Services Program, which provides varnish applications, dental screenings, and education and referrals for thousands of Missouri children. The Office of Dental Health provides education about the relationship between oral health and overall health as well as the prevention of dental disease. Dr. Miller is working for all Missourians to experience better oral health.

Dr. Miller graduated with distinction from the University of Missouri at Kansas City School of Dentistry and received a Master of Science and Certificate in Orthodontics at the University of Nebraska Medical Center College of Dentistry. In July 2022, she earned her Master of Public Health degree from A.T. Still University of Health Sciences.





Background



- Missouri seniors age 60+ make up 24.39% of the population
 - By 2034, Missouri seniors will make up more than 25% of Missouri's population (for the first time there will be more older adults than individuals younger than 18 years of age).
 - This gap will continue to widen as the population continues to age with Missouri seniors predicted to greatly outnumber children by 2060.

What is a Master Plan on Aging

A Master Plan on Aging is a living document that:

- Provides a clear framework to plan for ten years or more;
- Enables governors to communicate a clear vision and priorities for their state;
- Guides state and local policies of public and private programs toward aging with dignity;
- Reflects extensive input from the community, including people of all ages and abilities; and
- Allows the state to allocate funding or resources to implement initiatives from the Master Plan vs. reacting to individual stakeholder needs

Start with Why


- WHY: We all deserve to age with independence and dignity

Whole Person Health's Work in Year One: Understanding Vulnerabilities, Making Recommendations

Understanding Vulnerabilities, Making Recommendations

During the first year, the Whole Person Health Subcommittee will work to identify:

- What is Whole Person Health? What should it include?
- What baseline data / research / assessments are available (or should be available)?
 - Dental care
- What is working well that we should expand upon? What programs are working well?
 - Show Me Healthy Women (DHSS)
 - WISE Women: Well Integrated Screening and Evaluation for women across the nation
 - Alternatives for men? Screening to healthy lifestyles (male equivalent)
- What gaps and opportunities exist?
- Based upon this learning, what does the committee recommend?

Oral Health of Older Adults

Adults at Missouri's Senior / Nutrition Centers

- 296 participants 60-96 (mean = 74) at 24 senior or nutrition centers
- 52% of people with severe tooth loss (fewer than 20 teeth remaining)
- 23% of people with no natural teeth

Adults Living in Missouri's Skilled Nursing Facilities

- 253 participants 60-100 (mean = 76) in 22 skilled nursing facilities
- 74% of people with severe tooth loss (fewer than 20 teeth remaining)
- 39% of people with no natural teeth

Insurance?

- Medicare does not cover most dental care
- Medicaid only covers a limited number of dental services and does not provide dentures after teeth are removed
