Emergency PREPAREDNESS Report & Emergency GENERATOR Report

Results from the 2012/2013 Surveys of
Missouri's Licensed LTC Homes

Tornadoes, earthquakes, explosions, pandemics and other disruptive or disastrous events reported in the news every week remind us of the challenges these types of events create for vulnerable adults and their caregivers. This past fall (2012), the Section for Long-Term Care Regulation (SLCR) conducted its fifth annual **Emergency PREPAREDNESS Survey** for all licensed long-term care (LTC) homes in Missouri. The survey asked questions concerning the development and content of emergency plans. SLCR received **538** anonymous responses.

For the first time, we also conducted an **Emergency GENERATOR Survey** (2012/2013) that asked questions specific to each home’s electrical generator capacity. Power outages associated with extreme weather events are common. Sometimes the power outage is brief and at other times it can extend for long periods. Knowing which homes have emergency generator capacity and which do not, can assist local emergency planners in the allocation of resources before an event and identify those most in need during an event. **819** Missouri’s LTC homes completed the survey.

Response rates for each survey by level of care are as follows:

• Residential Care Facilities (RCF):	137 = 33% response rate	204 = 50% response rate

The data we gather from both of these surveys helps us identify opportunities for improving emergency preparedness within the LTC industry in Missouri. The results are aggregated in this report to be distributed to homes, local emergency management agencies and local public health agencies. In addition, Emergency Generator data is shared with the DHSS Center for Emergency Response and Terrorism for statewide emergency planning and preparedness purposes. Local health departments and local emergency management agencies, our partners in community and state-wide emergency preparedness, may also request the generator data for pre-event planning.

Analysis and Recommendations:

1. Increasing the collaboration and cooperation among emergency responders, emergency planners, local health departments and local healthcare providers improves the community’s overall emergency preparedness and medical response capabilities. LTC homes are encouraged to involve their local emergency management office, the local fire department and others in their emergency planning (EP) and to participate in local healthcare coalitions that might include hospitals, hospices and the local public health agency. The following data indicates the level of community engagement on the part of LTC homes:

- ↑ 80% involved their local fire department in the review of their EP (+12%).
- 22% involved their local Emergency Management office in the review of their EP (+/-0%).
- ↑ 49% participate in community emergency preparedness exercises (+3%).
- 57% collaborate with local healthcare providers or a healthcare coalition (new question).

2. Lessons learned from recent weather events or other disasters emphasize the importance of sheltering in place when possible to reduce the strain on the community’s resources during a period of high demand and to provide for uninterrupted care to LTC residents. This requires planning for food, water, medications, maintaining electric power and fuel replacement. Sheltering in place may not be possible; therefore plans should include alternate facility locations and realistic transportation options. The data provides the following indicators:

- ↑ 72% plan to receive/send residents to/from other LTC facilities (+21%).
- ↑ 73% plan for staff accompanying residents in transit (+11%).
- ↓ 71% plan for sheltering in place (-7%).
- ↓ 74% address staffing needs in their plans (-1%).
- ↑ Although difficult to measure, the survey shows an increase in supplies for food, water and fuel.
- ↑ Overall, there was an increase in key emergency contact information included in plans.

3. Training and testing is an important part of LTC emergency plans. Exercises can identify plan weaknesses and areas for improvement. Plans should include a specific training regimen for staff and an exercise/training schedule that tests different parts of the plan. Homes are encouraged to participate in community emergency preparedness exercises.
4. 819 of 1143 Missouri homes responded to the Emergency GENERATOR Survey. Analysis of the data reveals:
 - 35% report that they DO NOT have an emergency generator.
 - 65% report having an emergency generator (Keep in mind that the generators have varying capacity.)
 - 19% have generators that can power heating, ventilation & air conditioning (HVAC) and refrigerators (not exclusively). 53% of these use diesel; 20% use propane; 28% use natural gas.
 - 5% of homes do not have an emergency generator but are PRE-WIRED to accept a temporary emergency generator that will power HVAC and Refrigerators (not exclusively).

SLCR hopes these survey results and recommendations will assist homes and communities in their emergency planning efforts. SLCR will continue to provide information and resources to homes and long term care associations as we all work to ensure that Missouri long-term care homes are prepared for any type of emergency.
