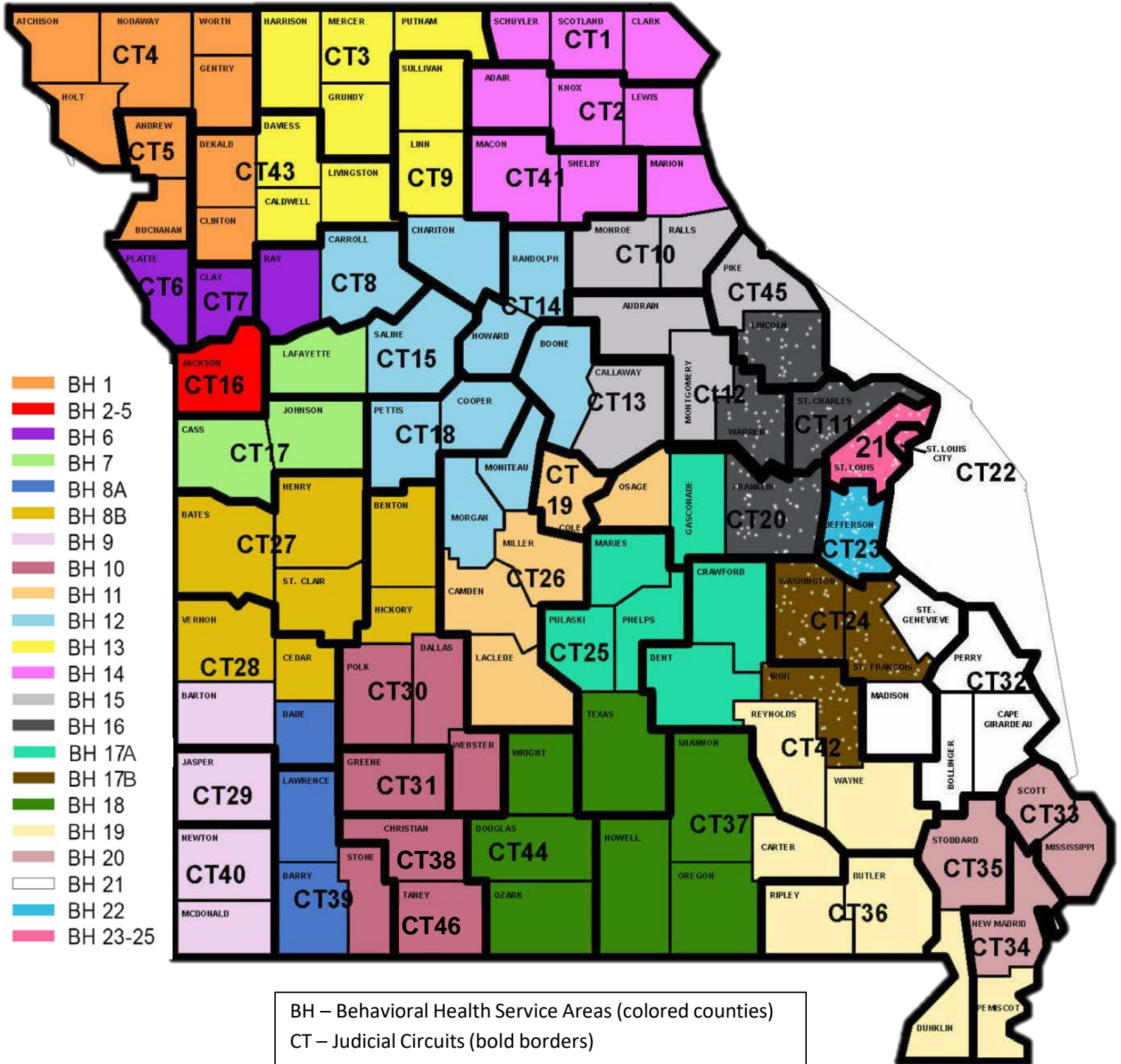


Community Mental Health Liaison Map
