As Lighthouse International does not provide financial aid for general eye care, prescription drugs, surgery or other medical procedures, we're glad to offer this guide to financial resources to meet a variety of your vision healthcare needs.

Social Security Benefits

Social Security Disability Insurance is a federal program that provides certain financial benefits to workers who have become disabled. To be eligible, you have to be “insured,” meaning that you have to have worked long enough and paid social security taxes. For eligibility requirements, visit the Social Security Administration’s website or call (800) 772-1213.

• **Supplemental Security Income (SSI)**

Supplemental Security Income is also a federal program, designed to help elderly and disabled individuals who have limited financial resources. It is intended to cover basic needs, such as food and shelter. For eligibility requirements, visit the Social Security Administration’s website or call (800) 772-1213.

Rehabilitation Service Agencies

A variety of payment options are available for vision rehabilitation services provided by organizations such as Lighthouse International (a non-profit, non-governmental organization). Many agencies offer a sliding scale and will develop a payment plan based on your individual circumstances. Agency staff may also help you identify funding sources, including state-sponsored service departments, local school districts, Medicaid and Medicare.

State Agencies for the Blind and Visually Impaired

Each state has a government agency that addresses the needs of residents who are blind or visually impaired. In some states, these are wholly dedicated commissions for the blind, and in others they are subsidiaries of the state's department of vocational rehabilitation. Services provided by these agencies may include: vocational training, job retention assistance, vision rehabilitation services, assistive technology training and funding for educational programs. Services are usually provided at no cost to eligible residents.

EyeCare America is a service of the Foundation of the American Academy of Ophthalmology that refers people to volunteer eye care professionals who accept Medicare/Medicaid or who waive co-payments and other fees. People without health insurance are also covered.

EyeCare America has several programs, including those that focus on diabetes, glaucoma, macular degeneration and eye health for seniors. Generally, program recipients must be US citizens or legal residents and must not have had an eye exam within the past three years. Eyeglasses, medicines, hospital services and fees of other medical professionals are not included.

People at high-risk for glaucoma and who are Medicare recipients may be eligible for an annual screening. High-risk people, as defined by the Benefits Improvement and Protection Act of 2000, include: individuals with a family history, diabetics and African Americans age 50 and older. You must pay 20% of the Medicare-approved amount after the yearly Part B deductible.

Vision USA is a service of the American Optometric Association and provides assistance to uninsured, low-income individuals and households. Program participants are referred to a volunteer doctor of optometry for a comprehensive eye exam. In some cases, eyeglasses may also be provided at no or low cost. (Note: At least one person in your household must be employed to participate in the program.)

Reauthorized in 2009, the Children's Health Insurance Program covers regular checkups, doctor visits, immunizations, prescription drugs, eyeglasses and hospital care for eligible children. Programs are administered by state governments, and eligibility criteria vary from state to state.

All applications must be submitted via e-mail according to the procedures outlined on the website. The grant periods are June 30 and December 31.

The National Association of Free Clinics has an online database of over 1,200 free clinics throughout the United States. Many free clinics provide general and specialized eye care in addition to other health services.

- **Find a Community Health Center Online**

The US Department of Health and Human Services offers this searchable online database of community health centers. Health centers are federally-funded and provide medical care and specialty services, including to patients who do not have health insurance or who have limited financial resources. Many of these centers offer optometric or ophthalmological services.

- **State Ophthalmologic Society or State Optometric Association**

These membership associations usually maintain a public list of the eye care providers in their state. Often, they will also have information about which doctors accept Medicare/Medicaid, or if any doctors provide low or no-cost eye exams.

- **Community Referral Services**

Many communities have information & referral services to help residents connect to resources such as health services and economic support programs. In some areas, these services are set up as call centers with a 211 or 311 phone number. Information & referral services may also be housed in local hospitals or community outreach organizations. You can usually find this kind of resource by contacting your local chamber of commerce or elected official's office.
